For what purpose and on what basis we process personal data

Trigona Dairy Trade BV processes your personal data for the following purposes:

- Sending our newsletter and marketing (facts & thoughts)
- Being able to call or e-mail you if this is necessary to be able to perform our services
- Inform you about changes to our services and products
- Offer you the possibility to create an account (facts & thoughts)

Automated decision making

Trigona Dairy Trade BV does not take decisions on the basis of automated processing about matters that may have (significant) consequences for persons. These are decisions that are made by computer programs or systems, without a human being (such as an employee of Trigona Dairy Trade BV) in between.



How long we keep personal data

Trigona Dairy Trade BV does not store your personal data for longer than is strictly necessary to achieve the purposes for which your data are collected. We use the following retention periods for the following (categories) of personal data:

Sharing of personal data with third parties

Trigona Dairy Trade BV does not share your information with third parties.

Trigona Dairy Trade BV only provides to third parties and only if this is necessary for the implementation of our agreement with you or to comply with a legal obligation.


Cookies, or similar techniques, that we use

Trigona Dairy Trade BV only uses technical and functional cookies. And analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferences. We can also use this to optimize our website. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that was previously saved via the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent for data processing or to object to the processing of your personal data by Trigona Dairy Trade BV and you have the right to data transferability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@trigonadairytrade.nl.



To ensure that the request for inspection has been made by you, we request that you send a copy of your proof of identity with the request. Make in this copy your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Social Security number (BSN) black. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.
